






#### 2019/2020 FY NOTABLE ACCOMPLISHMENTS

- In collaboration with the Department of Rehabilitation (DOR), TMI created an employment program for veterans with disabilities.
- Supported Employment assisted 89 individuals (an agency record) to obtain gainful employment (earning \$13 an hour or more).
- Assisted 10 individuals to find their first ever affordable housing and to live with minimal supports as they enjoy their new found freedom.
- 100% of parents/advocates who answered our survey reported that they are happy overall with TMI Community Living Services (CLS).
- 100% of clients who answered our survey reported that they are happy with the supports they receive from their CLS Facilitator/Roommate.
- TMI completed a comprehensive Disaster and Emergency Action Plan that greatly enhances the overall safety of all employees and clients.
- TMI received the Platinum Seal of Transparency from Guidestar.
- 100% of all donations went to our TMI Julie Casey Honorary Fund to directly assist our clients. TMI issued more than \$12,000 to clients for needs including rent, food, medication, clothes, and much more.
- TMI developed a staff wellness program (mind, body and soul). In the final quarter of 2019 it grew by 540% since its inception in early 2017.
- TMI provided more than 100 clients with community social activities and events through a program we created in 2016 called CONNECT.



# NEW PROGRAM: VETERAN EMPLOYMENT SERVICES

**Achieving Goals** 







The TMI Veteran Employment Services program is designed to assist veterans with disabilities to choose, obtain, and maintain employment commensurate with their career choice and vocational interests within San Diego County. Individual strengths and abilities, prior work experience, and career preference will be integral factors in determining placement. Vocational assessment, as well as social, psychological, communication, environmental, and medical needs will also be considered. The goal is to pre-screen and match qualified individuals with employers. TMI is confident that veterans with disabilities can achieve their employment aspirations with our assistance.

#### OUR PROGRAMS

#### A PLACE TO CALL HOME

Independent Living provides up to 80 hours/month of one-on-one support to adults with disabilities living in their own home. Services are focused on skill development. **Supported Living** assists people with cognitive and/or physical challenges to live independently or with a roommate. Personalized supports are dictated by a person's needs. We provide up to 24 hours a day of one-on-one support that may consist of live-in staff, shift staff or a paid neighbor who stops in on a daily basis.

#### A FOCUS ON FAMILY

As a licensed Resource Family Agency (License #370603102), TMI helps parents manage difficult decisions and obtain the relief and support they need. Resource Family Services are available for youth with disabilities who are unable to remain with their family of origin temporarily or permanently. Family Focused Services are designed to keep families together. Individuals thrive when they feel safe, secure and loved. This is the drive behind our belief that "all youth belong in families!"

#### INCLUSION MATTERS

Individuals with intellectual and developmental disabilities can absolutely enjoy the rewards of being a contributing member in society and have the satisfaction and pride that comes with having a job or volunteering. TMI's Supported Employment and Integrated Work/Community Integration Services programs work with individuals to secure and maintain gainful employment in the community if desired and also work in collaboration with local businesses to develop volunteer opportunities for our clients.



#### ADDITIONAL SERVICES

#### TAILORED DAY SERVICES (TDS)

TDS clients are encouraged to self-direct and participate in determining their program day. We are here to help our clients plan their day their way. With the anticipation of maximizing life satisfaction, this exciting program tailors our client's day based on their personal choices, hopes and dreams.

## ASSESSMENT & INTERVENTION SERVICES (AIS)


Our AIS program is designed to provide personcentered services to individuals within the context of family homes, group homes and independent living arrangements. AIS staff, with input from the Interdisciplinary Planning Team, provide youth and adult participants, families, support staff and/or caregivers the tools necessary to help manage, reduce, and/or extinguish targeted behaviors.

#### **EVOLUTION TO INDEPENDENCE (ETI)**

The goal of ETI is to provide the 'NEXT LEVEL' of business and educational services for individuals with developmental disabilities, including the Deaf and Hard of Hearing. The major emphasis of ETI services are 'Real World Ready' employment education that addresses the needs of individuals that are Deaf and Hard of Hearing, have difficulty with the mental processing of information, as well as 'first language' communication needs.

#### PAID INTERNSHIP PROGRAM (PIP)

The PIP is designed to encourage competitive, integrated employment (CIE) for our clients. CIE is full or part time work for which an individual is paid minimum wage or greater in a setting with others who do not have disabilities. The purpose of the program is to increase the vocational skills and abilities of our clients to gain experience and skills for future paid employment, or for the internship itself to lead to full or part time paid employment in the same job.



#### TMI EXPANSION INTO DOWNTOWN RIVERSIDE BRINGS NEW OPPORTUNITIES & INVALUABLE FRIENDSHIPS

In 2019, our first Integrated Work group started volunteering in downtown Riverside. Thu, Lacey and Haile, with the support of their TMI Job Coach Jennifer Wortman, make an amazing team! Two of the ladies have limited verbal abilities, but all have learned to communicate with each other to get the job done!

When Jennifer first came to TMI and met with these young women she was determined to help them find work sites that they would not only enjoy, but that could teach them skills in an environment aimed at people of their own age group. The group volunteer at Downtown Apothecary, a bath, body and home shop, and MP Couture, a women's clothing and accessories story, in downtown Riverside, as well as at The Grove Community Church restaurant in Riverside. The bond they have formed is evident in their work ethic and improved social skills. The ladies love working together!

"These ladies have become very bonded and are thriving in their current work sites," said Jennifer. "They operate almost as a perfect machine in harmony, naturally picking up where the other left off or filling in if a group mate can't complete something."

TMI's Temecula office opened in April 2008 and in April 2016 our Corona office opened. TMI now serves nearly 300 clients with intellectual and developmental disabilities, including autism, Down syndrome and

cerebral palsy, throughout Riverside County, with services for more than 1,000 clients throughout San Diego, Riverside and Imperial Counties.

#### TMI CLIENT WITH AUTISM SHINES ON STAGE WITH JASON MRAZ

Growing up, Paela, who is on the autism spectrum, would have never guessed that she would perform on stage with Jason Mraz in his new musical *Shine*. She was always incredibly shy, so the thought of even being on stage, let alone with Jason, was so hard to imagine that when it actually came true she couldn't believe it. The opportunity pushed Paela out of her comfort zone and helped her to make huge strides with facing her fears, which she knew she must do to seize this amazing opportunity.

In 2017, Paela joined Banding Together in San Diego, Jason Mraz' hometown. Jason was inspired to give back to local nonprofits by creating a musical based on the singersongwriter's catalog of songs including "I Won't Give Up," "I'm Yours," and "The Remedy." The musical presented by the Jason Mraz Foundation featured performances by local arts education nonprofit groups from Jason's own backyard including Banding Together, who brings music opportunities to individuals with special needs. Paela first met Jason when he joined Banding Together on stage at the Belly Up in Solana Beach for a Banding Together fundraiser.

In February 2020, Paela performed two sold out shows with Jason, Banding Together and other local nonprofit groups at the Spreckels Theatre in San Diego. Paela, who is inspired by Jason's work, as well as by Justin Bieber (who plays guitar and drums), performed on the drums. At first, performing made her feel embarrassed, but with each rehearsal her confidence grew and she found the courage she would need to perform in front of an audience of nearly 1,500 for each show.

"Each of these organizations was chosen because of their commitment to inclusive arts education and the advancement of equality," said Jason. "By shining a light on these programs serving our local community's youth, I want to underscore the importance of access to arts programming for all children in all communities – no matter their gender, race, ability level, sexual orientation, or socioeconomic status."

"TMI has continued open communication with Irene C. and all of our clients and families to ensure their safety and to offer our support and encouragement that we will get through this together," said TMI Executive Director Rachel Harris. "Many of our clients are confused and asking when they can return to their community program. We will make that happen as soon as it is deemed safe by Governor Newsom."

Irene C.'s mother, Norma, who became a TMI Job Coach a couple of years after Irene C. joined TMI, is grateful for the continued communication with TMI.

"TMI is wonderful," said Norma. "I'm happy about the open communication and that they are thinking of our children and their well-being during this time. It makes me happy to know that they are there."

Irene Balderas is Irene C.'s TMI Job Coach. Prior to Governor Newsom's stay-at-home order, Irene B. assisted Irene C. with volunteering in the community at Sunny Senior Health Care, Valle Vista Calvary Church, Salvation Army, Ramona Rehabilitation, Valle Vista Library, as well as at the San Jacinto Senior Center and Bread Basket Food Pantry, which are two of her favorite volunteer sites. At the Senior Center, Irene C. helps prepare meals for seniors in Hemet and San Jacinto and at the Food Pantry she helps organize and move food products for people in need.

Irene B. said that she is proud of the major changes that Irene C. has gone through since starting in her group. Irene C. needed a lot of encouragement to start tasks, because she was shy, but also because she lacked motivation. After several months in the program, Irene C. became a self-starter, open communicator, and when she finishes tasks and has nothing else to do she asks her coworkers in her group if they need help. "The TMI program has helped in developing Irene's confidence, drive, and independence," said Irene B. "I look forward to getting back out into the community with our clients to continue to assist them with being the best that they can be. I miss them."
