PROGRAMS

Integrated Work

Our **Integrated Work/Community Integration Services** are designed to meet the employment and community integration needs of individuals with intellectual and developmental disabilities who are Regional Center clients and over the age of 18. These services are funded by Regional Centers with dollars from the Department of Developmental Services at a 1:3 staff to client ratio.

Our programs offer a six (6) hour program day that generally begins at 7:30 am and ends at 1:30 pm and includes door-to-door transportation by a TMI Job Coach. Clients have a wonderful opportunity to actively assist in the development of their community schedules. Their participation in making decisions about their day reflects their unique skills, support needs and individual preferences. In addition, clients have the opportunity to access resources in the community such as libraries, fitness centers, restaurants, etc.

Supported Employment

It is the mission of the TMI **Supported Employment** program to support, enhance and educate the general workforce population on the contributing value of people with intellectual and developmental disabilities. Through personalized integration, training and advocacy, TMI helps to develop the capabilities and strengths of all people desiring to enter the workforce.

Our mission drives our work to ensure that all people have the right to attain dignity and self-respect in the employment sector.



ADDITIONAL SERVICES

Tailored Day Services (TDS)

Clients are encouraged to self-direct and participate in determining their program day. We are here to help our clients plan their day their way. With the anticipation of maximizing life satisfaction, this exciting program tailors our client's day based on their personal choices, hopes and dreams. The program allows clients to choose and customize day services to meet their individual needs at a 1:1 ratio with a Community Facilitator. Services are available through the San Diego Regional Center (8 hours per week/32 hours a month) and private pay (no hour limit).

Evolution to Independence (ETI)

ETI's goal is to provide the 'NEXT LEVEL' of business and educational services for individuals with intellectual and developmental disabilities, including the deaf and hard of hearing. In keeping with the principles of the California Lanterman Act, the major emphasis of ETI's services will be 'Real World Ready' employment education that addresses the needs of individuals that are deaf and hard of hearing, have difficulty with the mental processing of information, as well as 'first language' communication needs. Services include ASL interpreting, as well as training for Food Handler's Certificate, written DMV exam and CPR/1st Aid. Services are available for individuals and employers.
